**RESOLUTION AMENDING RESOLUTION R20080196 TO SET  
EXPIRATION DATES FOR FREQUENT USE MEDIA**

**WHEREAS**, Skagit County operates the Guemes Island Ferry (Ferry) between Anacortes, Washington and Guemes Island, Washington; and,

**WHEREAS**, the Skagit County Board of County Commissioners (Board) has adopted Resolution R20080196, establishing the passage fare schedule for the Guemes Island Ferry; and,

**WHEREAS**, on May 15, 2008, the Guemes Island Ferry Operations and Performance Round Table (Roundtable) met and discussed the restructuring of ferry fares for 2009. Based on this discussion, the Roundtable concluded that prior to implementation of a new fare schedule in 2009, it is necessary to set the expiration of all Frequent Use Media. Specifically, the Round Table recommends:

- All annual Senior / Disabled passenger passes, purchased after July 1, 2008, shall expire on June 30, 2009; and,
- All 10 and 20 Trip Frequent Use Media purchased after July 1, 2008, to include, Senior / Disabled Car and Driver, Vehicle and Driver and Motorcycle and Driver, shall expire on December 31, 2008; and,
- All Quarterly Frequent Use Media, purchased after October 1, 2008, shall expire on December 31, 2008; and,
- All Semi-Annual Frequent Use Media, purchased after July 1, 2008, shall expire on December 31, 2008; and,
- All 25 Trip Passenger Frequent Use Media purchased after July 1, 2008, shall expire on June 30, 2009; and,

**NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY ORDERED**, that in accordance with the foregoing, the Skagit County Board of Commissioners authorizes amending Resolution R20080196 to set expiration dates for Frequent Use Media as follows, and as shown in attached "Exhibit A":

- All Senior / Disabled passenger passes purchased after July 1, 2008, shall expire on June 30, 2009; and,
- All 10 and 20 Trip Frequent Use Media purchased after July 1, 2008, to include, Senior / Disabled Car and Driver, Vehicle and Driver and Motorcycle, shall expire on December 31, 2008; and,
- All Quarterly Frequent Use Media, purchased after October 1, 2008, shall expire on December 31, 2008; and,

- All Semi-Annual Frequent Use Media, purchased after July 1, 2008, shall expire on December 31, 2008; and,
- All 25 Trip Passenger Frequent Use Media purchased after July 1, 2008, shall expire on June 30, 2009.
